ALL SET-UP/DECORATING REQUIRED PREVIOUS YOUR EVENT, MUST BE SCHEDULED WITH THE SECRETARY OF THE SANDY BEACH YACHT CLUB.

RESPONSIBILITY OF PARTY SPONSOR

1. LEAVE CLUB IN "BROOM CLEAN" CONDITION. PICK UP ANY VISIBLE DIRT, DECORATIONS, FOOD OR CRUMBS. MOP ANY GREASY, STICKY FLOOR AREAS, INCLUDING REST ROOMS. WIPE OFF TABLE TOPS.
2. EMPTY TRASH CANS AND DEPOSIT INTO DUMPSTER. REMOVE ALL FOOD.
3. REMOVE ALL PARTY DECORATIONS PUT UP FOR THE EVENT.
4. MEMBER SPONSOR MUST BE IN ATTENDANCE. HE/SHE IS RESPONSIBLE FOR THE CLEANLINESS AND SECURITY OF THE CLUB, AND MUST BE THE LAST TO LEAVE AFTER ALL GUESTS ARE GONE.
5. ALL OF THE ABOVE MUST BE ACCOMPLISHED IMMEDIATELY AFTER THE EVENT, OR VERY EARLY THE NEXT MORNING. ANY QUESTIONS IN THIS REGARD CAN BE DIRECTED TO ANY FLAG OFFICER.
6. SPONSOR IS RESPONSIBLE FOR THE BUILDING, ITS CONTENTS, GROUNDS AND DOCK AREA, AND WILL BE BILLED ACCORDINGLY FOR ANY DAMAGE INCURRED DURING THE EVENT.

LIQUOR USAGE WHEN CLUB IS RENTED

1. USE OF PERSONAL LIQUOR IN THE CLUB HOUSE OR ON THE GROUNDS IS PROHIBITED WHEN THE BAR IS OPEN.
2. PERSONAL LIQUOR MAY NOT BE USED FOR EITHER FAMILY RELATED OR MEMBER SPONSORED PARTIES OR EVENTS. BAR SERVICE IS ENCOURAGED!

NOTE: APPROVAL FOR ANY CHANGES TO THE ABOVE MUST BE OBTAINED FROM THE SANDY BEACH YACHT CLUB SECRETARY AND THE BOARD OF DIRECTORS.
